Rules and Regulations

- As with all of our paces and events, we are guests on the property so please be respectful of the landscape, pedestrians and automobiles.
- Payment is required in advance of Pace day. Any payments still outstanding on Pace day will have a \$10 charge added per rider.
- Hard hats are required for all riders – no exceptions.
- Horses must be in condition. NBLA officials have the authority to disqualify any animal that is in distress.
- Passing of other teams on the course must be done at the WALK or risk disqualification. Proper trail etiquette is required at all times.
- Please keep all dogs on leashes, clean up after them.
- There will be no refunds unless the pace is cancelled or doctor/vet certificate is received before Pace day.
- Please bring water – none is available at the pace.
- Please clean up your trailer area upon leaving.
- Each rider or Junior Rider's parent/guardian must sign & turn in the Release/Disclaimer below in order to obtain a start packet.

Release/Disclaimer
